Refund/Cancellation Policy

Our outlined refund policy is designed according to Fair Consumer Practices. Should student be terminated or cancelled for any reason, all refunds will be made according to the following refund schedule:

1. Cancellation must be made in person or by certified mail.
2. All monies will be refunded if the applicant is not accepted by the school or if the student cancels within three (3) business days after signing the enrollment agreement and making initial payment.
3. Cancellation after the third (3) business day, but before the first class, will result in a refund of all monies paid, with the exception of the registration fee, equipment kit and textbooks if purchased from the school.
4. Refunds will be made within 30 days of termination or receipt of Cancellation Notice.
5. Student records are maintained permanently. However, for those students who are denied entry or dismissed from the academy records will remain on file for at least one year.

Termination Policy
